In 1970, STFA Soil Group was established in Turkey as a foundation engineering specialist company. In 2003, STFA Soil Group and Al Habtoor Engineering Enterprises formed a joint venture to work in the UAE market. For two years, the two companies successfully worked alongside each other on a number of prominent projects. On 1st January 2005, the two companies formalized the joint venture agreement by creating a new, shared company called the Al Habtoor STFA Soil Group (HSSG).
